Section 120.74 requires that each Board file an Annual Regulatory Plan (ARP).

The Statute was amended by HB 7023 effective June 1, 2015.

One effect of the amendment was to index the plan according to "law implemented," rather than by "rule" as it was last year.

Attached is a draft of the 2015-2016 ARP.

You will note page 3, which give information requested by 120.74(1)(c), lists items by statute. Those statutes correspond with last year's rules that were not changed.

A copy of last year's ARP is attached for your reference.

The plan must be approved and signed for further processing.
